Legislative Activity 115th Congress, second session

Budget Issues

Consolidated Appropriations Act of 2018 (Pub. Law No. 115-141)

- Enacted on March 23, 2018
- Funds the USPTO at \$3.5 billion

Bipartisan Budget Act of 2018 (Pub. Law No. 115-123)

- Enacted on February 9, 2018
- Establishes the federal budget for FY2018 and FY2019



Legislative Activity

115th Congress, second session

Agriculture and Nutrition Act of 2018 (H.R. 2)

• Contains a provision that amends the Plant Variety Protections Act to insert "asexually" into the Act

Building Innovation Growth through Data for Intellectual Property (BIG Data for IP) (S. 2601)

- Extends the fee-setting authority granted to the USPTO by the 2011 America Invents Act for a ten year period
- Requires the USPTO to report to Congress on its plans for improving patent and trademark examination through the use of "advanced data science analytics" to improve consistency of examination, detect common sources of error, and improve productivity
- Current fee setting authority expires in September 2018



Legislative Activity

115th Congress, second session

Support Technology & Research for Our Nation's Growth and Economic Resilience (STRONGER) Patents Act of 2018 (H.R. 5340)

- The House recently introduced the companion to Sen. Coons' STRONGER Act (S. 1390)
- Contains the same substantive provisions as the Senate version

Small Business Innovation Protection Act (S. 791 and H.R. 2655)

- Directs the Small Business Administration and the USPTO to develop partnership agreements that provide for the development and presentation of training materials for small business concerns relating to domestic and international protection of intellectual property
- S. 791 was approved by the Senate Committee on Small Business and Entrepreneurship and H.R. 2655 was approved by the House Committee on Small Business

Legislative Activity

115th Congress, second session

Preserving Access to Cost Effective Drugs (PACED) Act (S. 2514)

- Provides that tribal sovereign immunity cannot be asserted in reexamination, *inter partes* review, post-grant review or in an ITC exclusion proceeding
- An earlier bill introduced by Sen. McCaskill (D-MO) (S. 1948) would prohibit an Indian tribe from asserting sovereign immunity as a defense in an *inter partes* review of the validity of a patent

Oversight of the U.S. Patent and Trademark Office (April 18, 2018)

- Hearing before the Senate Judiciary Committee
- Some issues raised by Senators:
 - § 101 Subject matter eligibility
 - PTAB
 - Diversion of USPTO user fees
 - Promoting diversity in STEM
 - Patents for Humanity
 - Office of Policy and International Affairs
 - China IP problems
- Possible oversight hearing before the House Judiciary Committee in the coming months

Safeguarding Trade Secrets in the United States (April 17, 2018)

- Hearing before the House Judiciary Subcommittee on Courts, Intellectual Property and the Internet
- Focused on the effectiveness of U.S. trade secret laws, including the Defend Trade Secrets Act (DTSA).
- Witnesses:
