## **Key points of interest**

- Patent Term Adjustment
  - Overall PTA compliance of mailed actions: 83%
  - Overall PTA compliance of remaining inventory: 88%
- First action pendency is 14.8 months
  - Increase from 14.7 months in Q4 in FY19
- Total pendency is 23.3 months
  - Decrease compared to 23.8 months in Q4 in FY19
- Serialized growth rate is 0.7%
- Attrition rate is 3.8%




## FY 2020 filing trends

- Serialized filings increased by 0.7%
  - Compared to 4.9% growth in FY19
- RCE filings have decreased by 10.6%
  - Compared to 0.6% decrease this time last year
- Provisional filings have increased by 2.9%
  - Compared to less than 1% increase in FY19 (0.6%)
- Design filings increased by 4.1%
  - Compared to 0.8% increase in FY19



#### FY20 USPTO serialized filings by country of origin





### **FY20 USPTO filings by priority type**




- FY 2020 increase in serialized filings was driven primarily by continuations
- National stage applications, applications claiming foreign priority, and brand-new cases also contributed to growth


# **Continuation filing trends**

- Continuations are rapidly increasing
  - Tripled in a decade
  - Now account for nearly a quarter of all serialized filings
- Impacts workload and docketing practice
  - Makes first-in-first-out and workload balancing more difficult
- Large majority filed from allowed cases
  - 80% of continuations have a patented parent
  - 21% of issued patents spawn a continuation





# Serialized filings by entity status



- Ratio of entity status relatively stable
- Most growth appears to have come from large entities
