National Council for Expanding American Innovation (NCEAI)

• Background:

- Was identified as a USPTO initiative in the SUCCESS Act report of October 2019.
- Develop a national strategy on innovation and intellectual property and a plan of action that will foster the involvement of underrepresented groups as inventors-patentees, entrepreneurs, and innovation leaders.
- Execute a long-term comprehensive plan for continuing to build America's innovation ecosystem in areas that are key to the next technological revolution.
