ICANN updates

- ICANN's (Internet Corporation for Assigned Names and Numbers) current and future efforts that implicate trademark–related matters include the following:
 - Access to, and disclosure of, WHOIS domain name registration record information.
 - Procedures to be followed in any future rounds discussing new generic top level domains (gTLDs). No timeline for new gTLDs has been set.
 - Protections for inter-governmental organizations' (IGOs') acronyms in gTLDs. The working group addressing the matter will issue a preliminary report for public comment in August 2021.
 - Review of the Uniform Domain Name Dispute Resolution Policy (UDRP), which will begin this
 fall.
- The ICANN72 23rd Annual General Meeting Virtual Policy Forum will be held on Oct. 23-28, 2021.
